Recent Changes to Residential Housing Density in Mississauga

For the past several years, all levels of government have been focusing on how to address the growing housing crisis across Canada.



In Ontario, the provincial government passed the *More Homes Built Faster Act on* November 4th, *2022*. The legislation directed municipalities to make changes to their zoning bylaws by moving towards "as of right" zoning that permits three units on a residential lot. In October 2023, the federal government introduced a \$4 billion *Housing Accelerator Fund* for local governments across Canada. To qualify, cities were required to

submit action plans that promote the building of affordable housing as well as zoning changes that allow fourplex dwellings in low density residential communities.

On December 6, 2023, the City of Mississauga approved *new zoning and official plan rules* for fourplexes on low-rise residential lots. With these changes and a commitment to build 120,000 new homes by 2028, the city announced that it will receive a \$112.9 million grant from the federal government. The city is currently reviewing other zoning changes including permitting multiplex developments such as townhomes in residential neighbourhoods.

Residents of Hazel Heights are now seeing how these changes may impact on their community. The City of Mississauga recently received a proposal to develop 8 townhouse units on the south-east side corner of Carrington. The applicant is requesting that the city amend zoning and the official plan to permit this new development. A public hearing was held on January 10th and included a presentation from the applicant representative, city staff and an opportunity for residents to ask questions and express their concerns about the proposal. Following the public meeting, city councillor Joe Horneck followed up with a survey to gather additional community feedback about the proposal.

While the association recognizes the need for more diverse and affordable housing in our communities, it also believes that transparency and community engagement is essential to addressing resident questions and concerns. HHRA representatives met in early January with city officials to gather information about the proposal to share with our members. Councillor Horneck and the HHRA Board are working together to arrange a meeting with the representative of the developer in the next few weeks. Our intent is to follow-up on resident concerns about the potential impacts on the community and to discuss possible actions that can be taken to address these concerns.

We will continue to keep our members informed on this matter and any future proposals that may impact our community. Below are a few suggested links regarding the city's bylaw changes and housing action plan:

Update on Traffic Calming Study for Hazel Heights



At the request of HHRA, Mississauga city staff conducted a traffic study in 2023 about excessive traffic speed on three neighbourhood streets: Durie, Carolyn and Carrington Road. The city determined that there were speeding concerns on Durie and Carrington and will be forwarding the results to Peel Regional Police for enforcement considerations. In addition, the Road Safety Unit has been made aware of the speeding issues on Durie Road and Carrington Road and have added them to the list of locations to be considered for future physical traffic calming measures

and passive traffic calming measures. An electronic speed indicator has recently been placed on Carrington. HHRA will continue to communicate any updates to the community.

Home Break-Ins & Auto Theft Statistics in Peel Region, 2023



Crime statistics from the <u>Peel Police website</u> have reported 2685 home break-ins in Peel for 2023. This represents a 16.5% increase from the same time period for 2022. About 4.5% or 122 break-ins occurred in Ward 6 of Mississauga (Hazel Heights is a part of Ward 6). For 2023, there have been 9 reported break-ins in the Hazel Heights area.

Research and crime experts indicate that the following characteristics increase the chances of home break-ins:

- Corner lots and homes that back onto lots to open isolated spaces such as a ravine or park
- Poorly lit homes & properties that are not being maintained or "lived-in"
- Homes that leave their garage door open and unlocked



Peel police have also reported 8279 auto thefts for 2023, a 27% increase from 2022. About 3% or 241 of the thefts occurred in Ward 6 with 4 thefts being reported in Hazel Heights. A CBC investigation reported that many of these stolen cars are being exported abroad by organized crime with <u>specific vehicles</u> targeted by car thieves. Below are a variety of methods being used

today to steal cars including sophisticated technology that enable them to access cars in less than 10-15 seconds:

- Force entry such as breaking windows
- Looking for unlocked cars parked on laneways and public spaces like malls
- Using devices to detect FOB signals from and/or cloning garage door opener signals

Home & Auto Security

Crime experts suggest that effective home and auto security today requires <u>layers of protection</u> to deter, detect and slow criminals. The more you can delay an intruder, the more likely they will give up or lose the opportunity for a clean getaway.



Examples of **layers of home security** include the use of security cameras and sensors, home alarm systems, outdoor lighting, secure doors and windows, warning signs and Neighbourhood Watch.

Examples of **layers of auto theft prevention** include keeping cars locked and in the garage when not in use, placing a sensor in the car for tracking purposes and ensuring FOBS and automatic door entry devices are kept inside the home away from the front door or in a <u>Faraday bag or box</u>.

In some recent home break-ins, burglars have entered residences through the back entrance by breaking glass patio doors. Some methods to secure glass doors and windows include glass break detectors, window security bars and security films that hold broken glass in place and make it more difficult and time-consuming to access the house (It is recommended to use the thickest film (i.e. 8 or 14 mil). These security materials can be purchased at hardware stores, security companies and film installers such as Auto Serum and Window Film Solutions.
